Re: Conditional support for SB2

Dear Senator Ebbin and sponsors of SB2,

On behalf of the Virginia Society of Addiction Medicine (VASAM), the medical specialty society representing physicians and clinicians in Virginia who specialize in the treatment of addiction, we would like to take this opportunity to provide our conditional support for SB2, which would decriminalize possession of marijuana. While we support the effort to decriminalize substance use, we believe that Virginians would be better served if decriminalization was linked to contingencies that direct individuals to substance use disorder screening and treatment, as appropriate. Because we believe that Virginia should use this opportunity to steer patients towards treatment, we respectfully request that SB2 be amended to include referral to substance use disorder screening and treatment, as appropriate, as a contingency for civil possession offenses.

As outlined in the American Society of Addiction Medicine <u>Public Policy Statement on Marijuana, Cannabinoids, and Legalization</u>, VASAM supports the "decriminalization of marijuana, which would reduce penalties for marijuana possession for personal use to civil offenses linked to contingencies, such as mandated referral to clinical assessment, educational activities, and, when indicated, formal treatment for addiction or other substance-related disorders." While SB2 takes a commendable step towards mitigating the harmful impacts of criminalizing substance use, Virginia should use this opportunity to direct individuals to substance use disorder screening and treatment as appropriate. Other states, such as Rhode Island and Maryland, have paired decriminalization with drug education or assessment for substance use disorder and referral to substance use treatment. We encourage the Senate to follow this model and help connect Virginians to needed evaluation and treatment services.

VASAM shares the state of Virginia's goal of redirecting patients with addiction away from the criminal justice system and instead towards treatment. We applaud this decriminalization effort and respectfully encourage the sponsors to strengthen the bill by including pathways to access assessment and treatment.
