OVERVIEW

The ASAM Pain & Addiction: Common Threads Course is one of ASAM's longest running and most popular courses. This course is designed to develop learners' clinical skills and improve treatment of patients who fall somewhere in the gray area around pain and addiction. This course is designed for those in the addiction medicine field who already have some experience with pain and addiction.

This year's course will address some of the most common barriers and challenges standing in the way of effective treatment and provide learners with skills or resources to immediately use in their practices. Presenters will address challenges such as appropriately assessing, diagnosing or treating patients (particularly those with psychiatric comorbidities). Inaccurate diagnosis or referral can hinder treatment progress and impact patient trust in their health care providers. Presenters will also address complex, challenging patient cases such as patients on high doses of opioids or sedatives, patients with nicotine dependence, special patient populations, and many others. Lastly, presenters will review components of strong integrated practice settings and provide resources for learners to use in their own clinical practices. Many presentations will have a non-didactive component allowing participants to either self-reflect, review challenging cases, or engage with the presenters.

EDUCATIONAL PURPOSE

Participants will learn clinical best practices and new research developments for treating patients with pain and addiction and how to begin to integrate these techniques into their own practices.

LEARNING FORMAT AND METHODOLOGIES

This live course will include short sessions with deep dives into challenging topics. Many of the short sessions will include case examples, additional resources, or opportunities to self reflect. There will an interactive panel discussion and ample time for learners to engage with the presenters during question and answer sessions.

LEARNING OBJECTIVES

Upon completion, participants should be able to:

- 1. Distinguish between physiological dependence, substance use disorder, misuse, tolerance, and nonadherence in the context of pain.
- 2. Use physical exams, functional assessments, screening tools, collateral information, and other tools in a clinical setting.
- 3. Describe the interaction between pain, pain medication, addiction, and the patient's emotional or psychological state.
- 4. Make appropriate treatment decisions for patients with pain, addiction, and psychiatric comorbidities.
- 5. Explain the impacts of nicotine on pain treatment and develop methods for addressing nicotine use with patients.
- 6. Manage the complex treatment needs of pregnant populations with pain and/or addiction.

MI HASAM MOTIVATIONAL INTERVIEWING Workshop

OVERVIEW

The ASAM Motivational Interviewing Workshop is a new, interactive workshop designed to introduce and expand participants' knowledge on utilizing Motivational Interviewing (MI) in an addiction treatment setting. MI is a goal-oriented, collaborative counseling style that evokes a person's own motivations for and commitment to change. This workshop is designed for those in the addiction treatment field who are just beginning to explore MI and those who already have some experience.

Physicians, clinicians, counselors, and all those working with patients with addiction often find that one of the main barriers to effective treatment is the patients' perceived lack of motivation to make changes. Without motivation on the patient's part, making or sustaining progress regarding treatment goals can be difficult. MI is one technique clinicians can utilize to encourage patients to explore, recognize and overcome ambivalence to make positive changes. Participants of this workshop will be introduced to the key concepts and skills of MI and explore ways to effectively integrate MI into addiction treatment to help promote positive patient outcomes

EDUCATIONAL PURPOSE

Participants will learn about the basic principles and skills of MI in addiction treatment and how to begin to integrate these techniques into their own practices.

LEARNING FORMAT AND METHODOLOGIES

This live workshop is designed to be interactive, with many opportunities for participant engagement and discussion. Sessions throughout the day will be led by a team of MI experts and include a mixture of lectures, demonstrations, and skills building.

It is important for providers in the field of addiction to understand the evolution of novel psychoactive substances, who is using them, signs and treatment of acute toxicity, available laboratory testing, and what is known about long-term sequelae from use of these agents including the potential for addictive disorders and withdrawal in chronic use. This knowledge will allow providers to identify and manage patients at risk from complications of use of these substances.

Several more experimental markers hold promise for measuring acute alcohol consumption and relapse. This symposium will provide an update on the use of alcohol biomarkers in general clinical practice, with special emphasis on: the use of alcohol biomarkers as a guide to the diagnosis and treatment of AUD in primary care settings; the use of phosphatidylethanol (PEth) testing as a guide to treatment in patients with co-occurring HIV/AIDS and AUD; and the use of alcohol biosensors to monitor response to treatment in both specialty and non-specialty treatment settings.

POLICY PLENARY SESSION: STATE POLICY APPROACHES TO ADDICTION MEDICINE ACCESS AND QUALITY

While the federal government has taken some steps to improve access to and quality of addiction treatment in recent years, many states have also been busy passing a flurry of laws and writing regulations related to addiction prevention, treatment, and recovery. States hit hard by the opioid overdose epidemic have established Task Forces, declared states of emergency, applied for federal waivers to transform their Medicaid programs, issued naloxone standing orders, and established countless other policies to reduce opioid prescriptions, promote harm reduction strategies, fund treatment, or regulate addiction treatment services. This Policy Plenary, moderated by ASAM President-Elect Paul Earley, MD, DFASAM, will explore state-level approaches to improving addiction medicine quality and access, discuss examples of policies that have worked well and those that have had unintended consequences, and help equip attendees to be effective advocates for good addiction policies in their states.


Workshop Session Collateral Damage: Pregnant Women with Interruption of MAT Due to Incarceration

Utilizing three case studies of patients from real clinical practices, presenters will discuss the unique challenges facing pregnant, opioid-dependent women who become incarcerated. Frequently, this incarceration leads to interruption of medication-assisted treatment, which can have unintended and harmful effects in the lives of women and their families. Presenters will discuss a model for provision of induction and maintenance of MAT for pregnant, opioid-dependent women who are incarcerated, and hope to inspire interest and motivation for attendees to work to increase cooperation and collaboration between the correctional system and MAT providers in their areas.

The pharmacokinetics of novel fentanyl analogs (eg, their duration of effect or the amount of naloxone required for reversal) is not well described in published literature. While little is available in peerreviewed literature, much is written and sensationalized in the lay press regarding purported toxicity and symptoms inconsistent with opioid overdoes. As such, it is difficult to understand the potential effects on patients who are exposed to these opioids. Given the prevalence and morbidity of these agents, testing patients for fentanyl has increased relevance, and rapid immunoassays are under development. Some testing has been found to be beneficial to public health and law enforcement officials but clinical benefit is still unclear. This session will discuss what is known about these novel opioids and their impact on both clinical care and public health concerns

This session will review the implementation of primary care based recovery coaches coupled with integrated addiction treatment across four practices affiliated with a large academic medical center and the effect on acute care utilization for patients with substance use disorder. Presenters integrated treatment into primary care practices with the formation of multi-disciplinary teams of local champions, access to pharmacotherapy with buprenorphine and extended-release naltrexone, counseling, and recovery coaching. Presenters then evaluated the impact of this intervention on hospitalization and emergency department utilization by matching patients in intervention practices with similar patients in control practices and comparing utilization during the same nine calendar months before and after the intervention.

Reducing Alcohol-Related Emergency Visits: An Innovative Model of Care to Improve Outcomes

Alcohol use is a common cause of Emergency Department (ED) visits and accounts for a large proportion of 30-day ED re-visits. We developed and evaluated an innovative rapid access medical withdrawal management service direct from the ED that demonstrated reduced alcohol-related ED utilization and increased access to care for people with alcohol problems. Our Alcohol Medical Intervention Clinic (AMIC) provides collaborative, inter-agency care with hospital, community, and primary care providers. Successes and challenges in the creation of this novel service will be discussed, including the importance of program evaluation to guide service delivery, demonstrate outcomes, and inform funding proposals. Attendees will be able to identify opportunities to develop a similar service to manage alcohol problems in their region.

They offer medication management, and optional peer-support and psycho-education groups to individuals unable to access care in the community. The primary goal is to engage people by "meeting them where they are," and to initiate pharmacotherapy, followed by stabilization and eventually linkage to community-based treatment. This clinic also serves in a complementary role to an inpatient addiction consult team, the emergency department, the obstetrics department, as well as all outpatient departments, and provides a "consult and return model" for complex patients in the MGH primary care clinics who need stabilization.

Medications for Opioid Use Disorder: A Toolkit for Improving Practice (TIP) Indigo Ballroom E, Level 2

Through this publication, SAMHSA aims to provide up-to-date information about using medications to treat Opioid Use Disorder (OUD) in order to expand the use of effective treatments and to reduce the negative consequences of OUD. This five-part TIP reviews the use of buprenorphine, methadone, and naltrexone and other strategies and services that support remission and recovery. With so many individuals passing through the criminal justice system having a substance use problem, there are many millions of opportunities each year to reduce problematic substance use and promote public health and safety, almost all of which are missed. What should police officers, judges, and probation officers do when they believe reducing the substance use of individuals they encounter would benefit the user and/or society more generally? This workshop, based on a chapter in the forthcoming ASAM textbook, will highlight innovative ideas for reducing the substance use of individuals who are under criminal justice supervision and review evidence on program effectiveness.

Psychiatry for Non-Psychiatrists: The DSM-5 Express

An expanding body of research validates the efficacy of 12-step programs in assisting recovery, decreasing the financial burden of substance use disorders and improving lives. Several research-validated manualized techniques assist the clinician in effectively integrating Alcoholics Anonymous (AA) and its sister organizations into basic addiction care. This session will provide a hands-on understanding of the AA process. The leaders will create an inner and outer circle within the room; the audience sits in the outer circle observing a typical 12-step meeting being help in the inner circle. The workshop leaders will employ stop/start techniques derived from experiential therapy to process the unique, non-confrontational method of rending advice within a meeting. More importantly, participants will witness subtle didactic, supportive and transformational elements that occur in a typical 12-step meeting.



Integrating Addiction Treatment into General Medical Health Systems Indigo Ballroom AE, Level 2

General medical settings are opportune for the identification and initiation of addiction treatment. There is emerging evidence that collaborative care models have applicability to opioid and alcohol use disorders. The implementation of an integrated system of care may overcome the barriers to the effective application of chronic disease management for addictive disorders. The existing healthcare system has significant fragmentation, overall access problems, and specific inaccessibility to highly effective addiction treatments. 


